

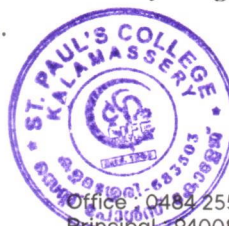
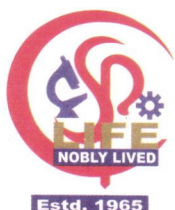
DECLARATION / UNDERTAKING
